Learning Objectives	Taking into account rituals, practices, ideas, the course aims at examining the relations of Christianity, during antique and late antique times, with other Mediterranean religions and cultures, especially Judaism and Paganism. Exploiting textual and material sources, different manifestations of Christianity emerging between Jerusalem, Antioch, Ephesus, Corinth, Alexandria, Carthage and Rome (and Constantinople) will be investigated.	
Prerequisites	Knowledge of the Italian language. Familiarity with the methodological tools of historical research. Aptitude for textual and archaeological analysis. Familiarity with late antique and/or early Christian history would be useful.	
Expected learning outcomes	 Knowledge and understanding Students will understand various aspects of the emergence of Christianity within the ancient and late antique Mediterranean culture, also in relation to other religious systems. Through an examination of textual and material sources, based upon critical historiography, they will be able to recognise different forms of such emergence and cultural crossings (rites, texts, practices, ideas). Applying knowledge and understanding Students will learn to apply to the history of Christianity a set of methodological reflections connected with the study of historical-religious phenomena: the emergence of Jewish monotheism in the Ancient Near East; the development of Scriptures deemed as sacred; the historical interpretation of Jesus between Judaism and Christianity; the sacrificial practices; the attribution of a soteriological and expiatory meaning to the sacrifice of Jesus Christ. Making informed judgements and choices Students will be able to independently examine and make informed judgements upon single case studies related to the diverse manifestations of Christianity in the Mediterranean cultural context. Communicating knowledge and understanding Students will be able to communicate the complex and multifarious relationships linking Christianity with other religious and cultural systems in the Mediterranean area, 	

	with reference to rituals, texts, practices, ideas. Ability to continue learning Students will be able to continue their learning process independently, especially by focusing on the multi-religious coexistence and cohabitation in the Mediterranean context from antiquity to the present.
Evaluation criteria	Students are expected to: -give proof of knowledge of antique and late antique cultural crossings of Christianity and other religious systems within the Mediterranean area, making the most both of textual/material sources, and of the secondary literature; -be able to apply their knowledge to more complex hermeneutical contexts, and in particular to some historical- religious reflections; -make informed judgements and critical examination of various case studies, with reference to the variety of manifestations and cultural encounters of Christianity within the Mediterranean context; -communicate knowledge and understanding of the multifarious relationships linking early and late antique Christianity to other religious and cultural systems - specifically Judaism - in the Mediterranean context; -be able to continue learning, investigating and historically assessing the various expressions of Mediterranean Christianity, with particular reference to the experiences of multi-religious coexistence and cohabitation from antiquity to the present day.
