	real occasion for the students to use actively their historical and archaeological notions, in order to interpretate the written monuments as complex documents, where contexts, objects and texts are strictly and reciprocally connected.
Contents	The goal of the course is to offer a general view about the epigraphic habit in the Early Christianity and its development towards the epigraphy of Byzantium and Western Early Middle Ages.  According to this view, the various topics will be presented and discussed on the base of a dossier of inscriptions, with particular attention to the use of epigraphic <i>medium</i> in the cultic and devotional contexts, between Late Antiquity and Middle Ages.
