Syllabus	
<b>Learning Objectives</b>	To develop the critical knowledge in the following topics: - the administrative and institutional history of the ancient Rome; - the epigraphic research methods.  To develop: - the ability of critical analysis of the ancient sources; - the ability to reconstruct of historical phenomena, taking into account the ancient sources (especially epigraphic).
<b>Course prerequisites</b>	General knowledge of Roman History: events; political-institutional and administrative patterns.
<b>Contents</b>	Rome and epigraphic writing: types of epigraphs, communication strategies; individual and communities' histories; the epigraphic habit of the rural settlements. The course will focus on an introduction to the basic elements of epigraphic science (inscription types, epigraphic conventions; dating criteria; epigraphic research tools, both traditional and digital up to the recent 3D representations); on the analysis and commentary of epigraphic documents related to institutional subjects. The course aims to give students the skills for epigraphic document edition.

<b>Expected learning outcomes</b>			
<b>Knowledge and understanding on:</b>	By the end of this course the student should be able to frame political-institutional and administrative aspects (local and central) in the general development of ancient Rome, for the republican and imperial period. The student should be able to read and interpret epigraphic sources taking into account the context in which they were created.		
<b>Applying knowledge and understanding on:</b>	The student will be able to reconstruct institutional and administrative patterns, from epigraphic sources, considering different kind of evidences (archeological, papyrological, numismatic and manuscript tradition); the student should acknowledge the specificities and the potentialities of each document, applying the historical research methodology.		
<b>Soft skills</b>	<ul style="list-style-type: none"> <li>• <i>Making informed judgments and choices</i> The student will be able to query historical sources and to formulate personal and motivated judgements, also taking modern bibliography in consideration.</li> <li>• <i>Communicating knowledge and understanding</i> The student will be able to describe and debate historical phenomena and processes, using specific vocabulary, to communicate a specialist and non-specialist audience.</li> <li>• <i>Capacities to continue learning</i> The student will be able to apply knowledge and skills acquired to learning and discussing new historical phenomena. Criteria for assessment and attribution of the final mark	The measurement of learning and the awarding of the final grade will be carried out through the verification of the students' acquisition of skills related to the interpretation of the political-institutional and administrative structures of ancient Rome, including through the interpretation of epigraphic sources; to the correct approach to the tools and methods of historical research; to the elaboration of personal, correctly argued, points of view about historical phenomena, with both scientific and popular purposes.
