| Assessment methods | Assessment methods will consist of a written and an oral exam. |
| | The first part of the exam is the written one and is composed of a guided written comprehension starting from an argumentative text taken from the press about topics dealt with lectures. Its analysis will cover text content by open and multiple choice questions and grammar. The total number of questions is 20 and lasts 50 minutes. Any dictionary or glossary may be used. Final mark is expressed on 30. |
| | The second part is the oral one (after having passed the written exam). It consists in reading and translating an institutional document and in answering to at least three questions dealt with all the topics regarding this teaching activity. |
| | It may be possible for students to pass 2 <i>in itinere</i> written parts before the main exam session about topics only dealt with lectures, namely laboratory of automatic transcriptions and translations. These parts are not compulsory and may be replaced by the final written exam. |
