Learning Objectives	The aim of the course is to provide students with the fundamentals of political science, with special focus on its characterizing topics and its conceptual framework

Contents	The subject of the course is an introduction to the topics of Political Science. In the first part, the institutional one, the topics of Political Science (forms of state and government, electoral systems, political participation, parties and movements, ...) will be addressed in a thematic way. In the second part, the key themes of political theory will be discussed through the method of matrices (conceptual maps).

Criteria for assessment and attribution of the final mark	The final mark is given through a point system, with 30 points being the best grade and 18 the minimum passing grade. Hence, the exam is considered passed when the mark is greater than or equal to 18/30. The oral test will focus on the topics indicated in the programme and will be aimed at verifying the student's knowledge of the subject, as well as his capacity for argumentation and independent judgement.
