Expected learning outcomes	<ul style="list-style-type: none"> • <i>Expected learning outcomes</i> (decline in relation to the Dublin Descriptors) (it is recommended that they are consistent with the learning outcomes of the CdS, reported in the A4a, A4b and A4c frameworks of the SUA, including transversal learning outcomes) • <i>Knowledge and understanding skills</i> The metrics for assessing learning outcomes are based on the score of the 15-minute computerised test with a test containing 15. The minimum score for passing is 9 out of 15. If the student succeeds in passing the test in such a short period, it means that he or she has developed the appropriate comprehension skills. <p>Applied knowledge and comprehension skills The expected result is an oral performance (applied phase) purified above all from intercalators and drops in</p>

To enter the world of work, one must replace bad habits (e.g. intercalators) with good habits (a fluid and supervised exposure); in addition, you need to be very focused on the work you are doing.</p> <p>The organisation of the oral test over a predetermined period of time and with the achievement of objective objectives, can accurately measure the degree of comprehension skills applied.</p> <ul style="list-style-type: none"> • <i>Autonomy of judgement</i> <p>The multiple-choice test is designed to stimulate independent judgement. Often the answers seem very similar: it is only autonomy of judgement that leads the student to the right answer.</p> <ul style="list-style-type: none"> • <i>Communication skills</i> <p>The expected result is a communication in the form of public speaking with a perfect control of one's own emotionality in order not to run into the errors that objectively penalize the metrics of individual voting.</p> <p>The achievement of the objective results set for the oral test are the direct manifestation of the optimal control of one's own emotionality. And therefore an improvement in one's communication skills.</p> <ul style="list-style-type: none"> • <i>Ability to learn</i> <p>The computerised test is able to objectively measure the expected degree of learning. Especially because it has to be done in a very short time. The oral test, which is based on objective criteria, can also accurately measure the expected learning ability. With a poor learning ability, the student encounters many problems in carrying out the telematics and the oral examination in the form of problem solving and public speaking.</p>
Contents	<p>The course is divided into two parts. In the first, the illustration of the general themes of public law: in particular, the freedoms, sources, principles of Italian and European law, the constituent elements of the State.</p> <p>In the second, the specific issues of public economic law with particular reference to those of more immediate relevance to current affairs (control of public finance and money, the ECB, privatisation, regulation of private finance, the market (internal and community), and competition).</p> <p>The topics are dealt with with reference to concrete events, with a strong practical slant.</p>

Metodi didattici	<p>Lezione frontale con verifica telematica e orale. L'esame, in forma orale, è preceduto da una prova telematica della durata di 15 minuti avente ad oggetto un test contenente di 15 quesiti a risposta multipla. Il superamento della prova telematica (conseguendo un punteggio di almeno 9/15) è rivolto a verificare l'apprendimento delle nozioni di base dell'intero programma. Nell'ambito della prova orale (con votazione espressa in trentesimi) lo studente, conformemente ai Descrittori di Dublino) è incoraggiato a svolgere l'esame sotto forma di problem solving e public speaking, anche in vista di una ottimizzazione delle capacità comunicative. Spetta allo studente scegliere se svolgere l'esame orale secondo la modalità tradizionale oppure con un'esposizione volta a stimolare la concentrazione attraverso le tecniche di problem solving e public speaking.</p> <p>Frontal lesson with computerised and oral assessment.</p> <p>The examination, in oral form, is preceded by a 15-minute computerised test containing 15 multiple-choice questions. Passing the computerised test (achieving a score of at least 9/15) is aimed at verifying the learning of the basic notions of the entire programme. In the oral test (with a score expressed in thirtieth) the student, in accordance with the Dublin Descriptors) is encouraged to take the exam in the form of problem solving and public speaking, also with a view to optimising communication skills. It is up to the student to choose whether to take the oral examination in the traditional way or with an exposure aimed at stimulating concentration through problem solving and public speaking techniques.</p>
