<b>Learning Objectives</b>	<p>To develop the critical knowledge in the following topics:</p> <ul style="list-style-type: none"> <li>-the administrative and institutional history of the ancient Rome</li> <li>-the epigraphic research methodes</li> </ul> <p>To develop :</p> <ul style="list-style-type: none"> <li>-the ability of critical analysis of the ancient sources</li> <li>-the ability to reconstruct of historical phenomena, taking into account the ancient sources (especially epigraphic).</li> </ul>
<b>Prerequisites</b>	General knowledge of Roman History: events; political-institutional and administrative patterns.
<b>Expected learning outcomes</b>	<p><i>Knowledge and understanding</i></p> <p>By the end of this course the student should be able to frame political-institutional and administrative aspects (local and central) in the general development of ancient Rome, for the republican and imperial period. The student should be able to read and interpret epigraphic sources taking into account the context in which they were created.</p> <p><i>Applying knowledge and understanding</i></p> <p>The student will be able to reconstruct institutional and administrative patterns, from epigraphic sources, considering differentes evidencies (archeological, papyrological, numismatic and manuscript tradition); the student should acknowledge the specificities and the potentialities of each document, applying the historical research methodology.</p>

	<p><i>Making informed judgements and choices</i> The student will be able to query historical sources and to formulate personal and motivated judgements, also taking modern bibliography in consideration.</p> <p><i>Communication Skills</i> The student will be able to describe and debate historical phenomena and processes, using specific vocabulary, to communicate a specialist and non-specialist audience</p> <p><i>Indipendent Learning Skills</i> The student will be able to apply knowledge and skills acquired to learning and discussing new historical phenomena. The student will be able to independently apply acquired skills to different contexts.</p>
