Course prerequisites	Knowledge of ancient Greek language.

Teaching strategie	The course is based on a constant interweaving of face-to-face and laboratory teaching: theoretical investigation of the most relevant aspects of Greek writings is accompanied by direct examination of epigraphs, manuscript books and documents (in paper and/or digital reproduction) so that a critical awareness of the methodological tools of paleographic analysis is developed and the ability to connect the latter with the historical and cultural contexts of origin and use of the evidence
