those required for admission to the degree course. No prior knowledge of
French is required, however students who have never studied French are invited
to attend the <i>Laboratorio di Lingua francese</i> .

Assessment	
Assessment methods	The oral test covers the theoretical topics of the course (history and practice of translation), the reading and translation of a short passage from the anthology of texts provided to the students, and commentary on the translation.
Assessment criteria	Knowledge and ability to understand on It will be assessed whether the student: - knows the main syntactic and grammatical structures of the French language; - can orientate himself/herself among the fundamental stages in the history of translation; - is able to identify the main translation procedures; - knows the fundamentals of translation criticism.  Applying knowledge and understanding on It will be assessed whether the student: - knows how to translate literary texts in French of average difficulty; - can recognise and apply the various translation strategies autonomously and appropriately.  Making informed judgments and choices
	It will be assessed whether the student is able to conduct an analysis and critique of translation (his/her own and others') as outlined by Berman.  Communicating knowledge and understanding It will be assessed whether the student is able to comment clearly and effectively on a literary text and its translation, making use of specialist vocabulary.  Capacities to continue learning It will be assessed whether the student: - knows how to use linguistic tools, including multimedia, appropriately and autonomously; - has acquired the basic tools to undertake linguistic-literary research.
Final exam and grading criteria	The final grade is awarded in thirtieths. The examination is considered passed when the mark is greater than or equal to 18.  18-21: The student demonstrates basic and sometimes incomplete knowledge of the content and expounds it in language that is not always adequate. The arguments provided are not always satisfactory. The student's knowledge of French is sufficient.  22-25: The student shows basic knowledge of the content and explains it in
	partly adequate language. The arguments provided are satisfactory even if generic or notional. The student is able to translate simple texts correctly.

	26-28: The student demonstrates good knowledge of the content and uses appropriate language. The arguments provided are satisfactory. The student is able to translate texts of average complexity.
	28-30: The student demonstrates excellent knowledge of the content and expresses it in consistently adequate language. Arguments are valid and consciously delivered. The student is able to translate more complex texts correctly.
	30 cum laude: The award of honours is reserved for students who, in addition to the skills described above, also demonstrate a marked versatility in intertextual connections, in the ability to analyse and interpret one or more texts.
