| | evaluate methodologies; this serves to develop an awareness of differences that is the basis of independent judgment. In particular, students will learn to analyse not only the sources but also the ideological theory and background. <i>Communicative Abilities</i>: study of literary texts facilitates the acquisition of a more refined vocabulary and more structured syntax. The development of tools for textual analysis enables the student to express complex concepts. The result will be a notable improvement in students' use of Italian, a high level of which is to be considered essential for any post-graduate. |
