The student, through the acquisition of basic notions of contemporary philosophy of language in the context of deconstructionism, will increase his / her skills required for the power offered by the discussion and for the power developed the issues related to the relationship between verbal and non-verbal text in a way critical and autonomous. The theoretical study linked to the concept of writing will also allow the knowledge acquired to be applied also to new theoretical contexts and to objects of study not strictly treated during the course, developing the ability that is particularly useful in continuing the studies.
