<b>Learning Objectives</b>	The aim of the course is to provide students with the basic knowledge of the European, national and regional social security regulatory framework, also with reference to the discipline applicable to foreign workers, as well as the ability to describe and analyze the topics covered during the course.
<b>Course prerequisites</b>	Basic knowledge of labour law
