Expected learning outcomes	<p>The course aims to acquire knowledge of the main legal rules of the international community, as well as those relating to 'private' international law, also through the analysis of regulatory sources and jurisprudential cases, promoting development of:</p> <ul style="list-style-type: none"> <li>- knowledge and understanding, analysis, critical interpretation of sources and problem solving;</li> <li>- the ability of applied understanding of the knowledge acquired in concrete cases, also for the purpose of their use in carrying out work activities within international organizations;</li> <li>- autonomy of judgment and communication skills, as well as learning ability and capacities to continue learning.</li> </ul>
