Contents	The course develops starting from the well-known Aristotelian distinction of reason in <i>páthos</i> , <i>éthos</i> and <i>lógos</i> . The <i>nómos</i> is not unrelated to <i>páthos</i> . Quite the contrary. There are emotions that reveal the juridical sense of facts and the onto-existential function of law, forming the content of the "aesthetic" judgments, before the philosophical reflection and the logic of normative language. The results of the <i>Rhetoric</i> are different. They are gained through the analysis of the subjective judgement and the partial decisions of the jurists, on the side of the "great division" (within the judicial field) between truths of the premises (the propositions on rules and facts actually happened in a specific case) and validity of the conclusion (the verdict). Finally, with <i>Metaphysics</i> , the logic (or ontology) of legal existence turns into the science of some universal principles of law, and of the legal process in particular, showing its cause in the <i>Lógos</i> .
