Content knowledge	"Local and Global: Romantic-era Geographies and Histories"
	This course explores the literature of the romantic period from a multifocal
	perspective, which takes into account Britain's changing politics and society. The
	decades between the end of the eighteenth and early nineteenth centuries
	marked a crucial phase in the formation of British identity, as inextricably
	related to Britain's profile as an expanding empire and a global power. At the

	same time, Britain maintained the sense of its own identity in its local communities, as exemplified both in Austen's provincial society and in the "low and rustic life" that takes shape in the experiment of <i>Lyrical Ballads</i> . The course will consider a number of texts and a variety of genres and forms, highlighting the modes of their interaction with the undergoing global changes.
