Contents	The second year course of English Literature focuses on some specific aspects of 18th and 19th British literary literature, and related contexts. Along with locating literary texts and cultural processes, special attention is devoted to their resonance texts in contemporary literature culture through several forms of rewriting and adaptation also in new media.
Course program	Titolo: Negotiating Identities: Dickens's Legacy in a Cross-cultural World
	Within the wider context of 19th century literature, this course focuses on the Victorian Age and on its far-reaching

	resonances in the contemporary literary and cultural scene. The course offers an analysis of <i>Great Expectations</i> by Charles Dickens, which particularly raises such thorny issues as the negotiation of identity across differences of class, nation and culture. The course will also focus on two one of the most remarkable examples of postcolonial texts 'writing back' to the English literary canon: <i>Jack Maggs</i> (1997) by the Australian novelist Peter Carey, and <i>Mister</i> <i>Pip</i> by Lloyd Jones. Both texts explore the notion of cultural identity in the relationship the British Empire and its colonies.
