Knowledge and understanding on:	<ul style="list-style-type: none"> ○ The student at the end of the course is expected to acquire a solid mastery of the basic knowledge relating to the field of criminology, both about theoretical frameworks and to research and application methods, as well as to the essential aspects of the psychological and sociological

	<p>disciplines that are interdisciplinarily involved in the understanding of deviant behaviour and its aetiological context and must be able to understand the essential conceptual cores and reinterpret them for the analysis and understanding of the problems in the field of primary, secondary and tertiary prevention of crime and victimisation. The student will be able to reuse and apply the acquired knowledge and skills to identify and understand the educational emergencies and problems related to intervention and socio-educational services in the area of criminality and deviance proper to the field of intervention of his/her professional profile. These results will be pursued using lectures, in-depth seminars, and participation in study and research initiatives of the Department (conferences, study seminars, student services, etc.).</p>
<p>Applying knowledge and understanding on:</p>	<p>○ The student at the end of the course is expected to acquire the ability to use the criminological knowledge acquired during the course in an appropriate, effective, and flexible manner, translating it into professional skills, and will therefore be prepared to grasp the problematic nature of educational situations in the prison and extra-custodial context of alternative measures to detention, prevention, and reduction of deviance, discomfort and social disadvantage, analysing them from different points of view (social, cultural, psychological) in order to formulate, autonomously, adequate intervention hypotheses, also in relation to subjects at risk and/or vulnerable categories such as deviant minors, immigrants, women, drug addicts, ex-convicts. He/she will also be prepared to design, organise and set up, implement, manage, and evaluate continuous training interventions and processes in the public and private spheres, with the aim of preventing deviance and dysfunctional behaviour in organisations, such as training in codes of ethics and anti-corruption, etc. The achievement of these objectives will be pursued through lectures, classroom discussions of technical-scientific problems related to paradigmatic cases, and practical exercises.</p>

The student must be able to use and apply critically and autonomously the strategies, techniques, and tools of continuous training design in the field of childhood and pre-adolescence education, applying working and research methods and techniques to manage teaching/learning activities, with specific attention to the prevention of adult and juvenile deviance and socialisation to legality. The teaching methods and tools for achieving the indicated objectives will be as follows: frontal lessons, and in-depth seminar activities. • Communicating knowledge and understanding <ul style="list-style-type: none"> ○ At the end of the course, students must be able to demonstrate their possession of adequate communicative-relational and social skills useful for building educational relationships, for the organisation and management of groups, and for teamwork and inter-institutional liaison, with particular reference to the observation and treatment team and group in prisons and the multidisciplinary intervention team in extra-prison settings, as well as team working in the field of training applied to the prevention of deviance and socialisation to legality.
