<b>Learning Objectives</b>	The course aims to draw an analytical framework on the causes of the inefficiency of the food chain, with specific reference to the distribution of value, and the correlation with the development of illicit phenomena such as the caporalato in agriculture. During the lessons will be deepened the regulatory instruments of contrast to the caporalato and the most recent European and national legislative interventions related to the sustainability of the agricultural enterprise from a social, environmental, economic and legal point of view.

<b>Expected learning outcomes in terms of</b>	
<b>Knowledge and understanding on:</b>	The study of the phenomenon of illegal exploitation of work in agriculture will allow the student to acquire specific knowledge about the most important issues of the primary production system, including the social and economic aspects, as well as legal characters. The observation of the issues related to the distribution of value, the pricing of the product and European agricultural policies on the sustainability of the agricultural enterprise, will allow students to acquire specific skills both in reading and understanding national and European legislative texts, and in the ability to analyze social and economic phenomena underlying the most recent legislative choices, refining the autonomy of judgment.
