Expected learning outcomes	The course aims to provide students with the knowledge of the legal discipline of religious bodies and non-profit entities, considered as intermediate subjects of the Italian legal system, who interact with public institutions, with public bodies and private subjects according to the pursuit of the aims of common interest within the nation.
