 GIVEN the Regulation of the “Summer and Winter Schools” (R.D. 26.05.2016 no. 1543);
 GIVEN the proposal for setting up the Summer School *“ADR: Current and Evolving Challenges”*;
 GIVEN the decision to activate the aforementioned Summer School taken by the Council of the Ionian Department of Law, Economics and Environment (13.06.2016);
 GIVEN the decision taken by the Administration Board on 31.03.2016 for the University of Bari to join the Foundation *“Osservatorio sull’uso dei sistemi ADR”*;
 GIVEN the decision taken by the Academic Senate on 19.07.2016;
 ASCERTAINED that the Summer School’s order complies with the Regulations of the University of Bari Aldo Moro;
 GIVEN its own decree founding the Summer School (R.D.)

DECREES

Article 1

For the academic year 2016/2017 a competition is launched to be admitted in the International Summer School *“ADR: Current and Evolving Challenges,”* established by the University of Bari Aldo Moro – Ionian Department of Law, Economics and Environment – and the Foundation *“Osservatorio sull’uso dei sistemi ADR”*.

Article 2 Admission/Inscription requirements

Candidates are admitted provided that they meet one of the requirements listed in the Table below. Candidates must fulfill such requirements at the deadline for the submission of the application. Titles acquired in foreign Universities need to be recognized as an equivalent to those required herein. Such equivalence is limited to the admission at the Summer School and it will be appraised by the Commission appointed by virtue of Article 4.

Article 3 Application

Candidates must fill out the application form being available on the website <http://www.uniba.it/didattica/corsi-universitari-di-formazione-finalizzata/summer-school>

The application must be sent by and no later than **31.08.2016** under penalty of the exclusion from the admission procedure.

The application, with revenue stamp, must be signed and accompanied by the required documents. It must be sent to “*Università degli Studi di Bari Aldo Moro – Direzione Offerta Formativa e Servizi agli Studenti – Sezione Post laurea – U.O. Corsi di Perfezionamento e Alta Formazione – Area Protocollo e Gestione Documentale Palazzo Ateneo – Piazza Umberto I, n. 1 - 70121 Bari, Italy*”.

The required documents are as follows:

- Copy of the residence permit or copy of the related request (for citizens of non-EU States whose residence permit is mandatory);
- Copy of ID;
- Copy of the fees payment.

The fees may be paid:

- by postal account n. 8706, payable to *Università degli Studi di Bari Aldo Moro*, with the title of the Summer School;

Application and attached documents may be sent as follows:

- by hand delivery from Monday to Friday (10:00-12:00) to the “*Area Protocollo e Gestione Documentale di questa Amministrazione (Palazzo Ateneo), Piazza Umberto I – 1- Bari*”, excepted from 16th to 19th August 2016; or
- by certified mail (PEC) to **universitabari@pec.it** submitting copy of the signed application accompanied by a copy of ID. Documents must be sent only in PDF format.

The application must also be sent in copy to the Director of the Summer School, Professor Antonio Leandro (antonio.leandro@uniba.it).

Documents and certificates shall be submitted without a revenue stamp, in accordance with Article 1

of the Law no 370/2008; if written in a foreign language, they shall be accompanied by a certified translation in Italian, declared a true translation of the foreign text by the relevant Italian diplomatic authorities (Embassies/Consulates) or by an official translator.

The University does not bear any responsibility for the loss of correspondence due to incorrect or incomplete addresses or late or no notification of change of address of the applicants. The University also declines any responsibility for errors in the transmission.

Article 4 Commission for the Admission

The Commission for the admission to the Summer School is appointed by Decree of the Rector or Decree of the Director of the Ionian Department.

Article 5 Admission Procedure

Article 6 List of admitted candidates

The admission procedure and the list of admitted candidates will be approved by Decree of the Rector.

Such publication will have effect as a notification to the successful applicants.

Article 7 Privacy

The University of Bari Aldo Moro, in accordance with Legislative Decree 30.06.2003 no. 196, shall use the candidate's personal data exclusively for institutional and selection purposes.

Article 8 Final provisions

No communication will be provided as to the admission to the Summer School.

The certificate of attendance on vellum paper shall be released under request at the cost of € 67.60 to be paid by postal account no. 8706 to *Università degli Studi di Bari Aldo Moro*: the request for the certificate must be submitted before the final examination of the Course with enclosed copy of the payment.

The University checks the veracity of candidates self-certifications. In case of false statements, the candidates will be excluded from the selection procedure, or revoked if already enrolled after having passed the selection, subject to the penalties provided by Article 76 of Law no. 445/2000.

Citizens of non-EU States may apply to the Summer School provided that they are regularly admitted in Italy and may use the declaration forms of Articles 46 and 47 of D.P.R. no. 445/2000 according to Article 3 of the same D.P.R. no. 445/2000.
