**The University of Bari Aldo Moro announces the Summer School in cellular, behavioural and cognitive neuroscience for the 2021/2022 academic year.**

**Application deadline: July 10th, 2022, 23:59 (Italian time)**

**Positions: 33**

**Duration: 1 week (Sept 19-23, 2022), 92 hours (lectures and lab)**

**CFU/ECTS: 4**

**Venue: Bari (Italy)**

**Official language: English**

**Fee: free of charge. Costs of the Summer School are financed by ADISU – Regione Puglia, in partnership with MASMEC Spa**

### **1. Admission requirements**

Applications for admission to the selection process are accepted from candidates regardless of gender, age and nationality, who hold a Bachelor or a Master's Degree equivalent to the Italian Laurea Triennale or Laurea Magistrale, in terms of duration, level and subject area, considered suitable by the Admission Committee for the only purpose of the admission to the Summer School.

### **2. Application**

#### **Applicants with a foreign degree.**

The application for admission must be completed and submitted by **July 10th, 2022 – 23:59** ((Italian time) through the online system <http://www.studenti.ict.uniba.it/esse3>.

The online admission procedure consists of the following phases:

Registration on the website of the Italian University esse3:

- a) <http://www.studenti.ict.uniba.it/esse3/AddressBook/ABStartProcessoRegAction.do>  
You will be asked to include your personal data, residence and qualifications in your possession. The registration of your qualifications is used as Substitutive declaration of certification (according to the Decree of the President of the Republic no. 445 of 28<sup>th</sup> December 2000 and subsequent amendments and additions). At the end of registration, temporary Username and Password shall be assigned to access the reserved area for the subsequent enrolment phase of selection.

If you already have the access credentials to the reserved area (for instance as former student of the University of Bari), move directly to point b). In the event of forgotten password

- b) Completion of the application for admission:  
By accessing the reserved area and clicking on "*Concorsi/Test di ammissione*" (*Competitions and Admission tests*), choose the type and title of the course you apply for.

Transmission of the following documents to [alta.formazione@uniba.it](mailto:alta.formazione@uniba.it) (please enter in the subject field, "Admission – MOONRISE"):

- dated and signed CV in English, preferably based on the European model, (specifying the type of degree obtained, the issuing University, graduation date and final score);
- copy of the degree certificate
- copy of I.D. or passport;
- other documents certifying any academic titles and education qualifications useful to attest the candidate's research skills and abilities (Diploma Supplement, Transcript of records, PhD, post degree course, copy of High School Diploma, research activities, *participation in conferences*, seminars or workshops, scientific publications, motivational letter);
- the duly signed application for admission generated by the online system Esse3.

The above-mentioned documents must be sent no later than **July 10<sup>th</sup>, 2022**.

The documents must be produced in PDF format. Other formats or photos of the documents will not be accepted.

Non-compliance with the deadline indicated for the submission of the application and the transmission of the above-mentioned documents by **July 10<sup>th</sup>, 2022** implicates the exclusion from the selection.

If upon expiration of the submission of the applications for admission the number of candidates is not enough to achieve the minimum number of expected applications required to activate the Course, it may be decided to reopen the deadline of this announcement.

Any statements or false documents provided by applicants will be prosecuted under Article 76 of Presidential Decree 445/2000 of the Italian law.

### 3. Selection

The selection of eligible applicants will be carried out by the Admission Committee, designated for this purpose, on the evaluation based on the following criteria:

- Bachelor: max 5 points;
- Master's Degree: max 8 points
- PhD: max 20 points
- Post Degree research activities: max 15 points;
- Other educational courses and participation in conferences, seminars or workshops: max 2 points;
- Scientific publications: max 8 points;
- Motivational letter: max 2 points.

Overall score of 60 points available.

Preference will be given to studies relating the topics of the Summer School.

### 4. List of admitted candidates and enrolment

The applicants ranked in the first 33 places will be considered winners and eligible to participate

in the Summer School. In *the event of equal score*, the *youngest candidate* will be preferred.

The publication of the selection results is considered fulfilled, the admitted candidates will not receive any personal message.

The admitted candidates to the Summer School must, under penalty of exclusion, enrol through the appropriate online procedure within the terms that will be announced together with the publication of the ranking list, by accessing the reserved area of the online system Esse3 (with the same credentials used to complete the application for admission) and choosing the functions in order:

1. Enrolment > Courses with restricted access;
2. Payments > (Euro 16.00 - virtual stamp duty + Euro 4.13 - insurance policy contribution).

Applicants who do not submit their enrolment and pay the contributions (by the scheduled date) lose their right to participate in the Summer School and their position will be offered to the next eligible candidate in the ranking list.

## 5. Payment methods of fees and contributions

Pursuant to current legislation on electronic payments to public administrations, the payments of taxes and contributions can be paid through the PagoPA system, promoted by the Italian Prime Minister's Office and managed by AgID. Payments can be made also online by credit/debit card. The Offices of the Post Graduate Section will not send to the students the invoices which will be available on the Esse3 personal page under the heading Payments

## 6. Frequency, withdrawal and final certificate of attendance

Frequency: To obtain the final certificate of attendance, the participants must have fulfilled at least 70% of the all activities.

Withdrawal: the participants may submit at any time an instance of withdrawal. This is irrevocable and it must be addressed to the Director of the Summer School.

Certificate of attendance. At the end of the Summer School a *certificate of attendance* will be issued by the Director to everyone who has attended at least 70% of lessons and applications.

## 7. Privacy

The University of Bari Aldo Moro guarantees the processing of personal data of the learners, acquired with the registration and enrollment or through any other specific changes to the collection, for the performance of its institutional activities, within the limits established by the Italian and European laws.
