Expected learning outcomes	<p>The course aims to give students the tools to understand the principles of Civil Law, in accordance with the Constitutional Principles and the Italian-European legal sources' system. At the end of the course, students will be able to read and understand legal and judicial texts. They will understand notions and principles at the basis of the Civil Law System related to Successions, Donations and Business.</p> <p>Students will be able to evaluate the Private Law consequences on citizens' behavior and will be able to master language skills that will enable them to interact with law practitioners. Furthermore, they will be able to solve practical juridical cases.</p>
