| Contents | <p>Forensic Psychopathology and Psychology are sciences that span all psychiatric and psychological aspects of Law in all sectors and fields, including occupational and insurance law, applied to assessment and treatment aspects. Psychodiagnostic tests are essential tools in clinical and forensic activities pertaining to the forensic psychopathology and psychology domains. The course is intended to provide attendees with sufficient updated training in the use of psychodiagnostic methods, a necessary complement to clinical, medico-legal, forensic psychology and psychiatry investigations in the occupational and insurance sectors.</p> |
| Course program | <p>Assessments of fitness for work, the related insurance aspects, of job-related stress risks, abuse and violence at the workplace, where important problems like mobbing, burn out, the contribution of institutional checkups in dysfunctional work contexts often involve professional consultancy with psychologists. The acquisition of clinical tools supporting such assessments in medico-legal, occupational medicine, forensic psychology and psychiatry ambits, to deal with the delicate issue of the job as the expression of the person's existential agenda. The correct use of psychodiagnostic tools applied to support such assessments is essential as a means of preventing psychosocial risks and violence at the workplace. In fact, the management of dysfunctional organizational factors affecting individual workers (job-related stress and other psychosocial risks assessments) is essential in the prevention of individual work-related disorders due to intentional acts (harassment and violence) or linked to poor management of work organizational aspects (individual stress).
