Expected learning outcomes	<p><i>Knowledge and understanding</i></p> <p>At the end of the course, especially through the use of suitable and advanced study texts indicated in the program, the student should have a solid grasp of basic knowledge regarding the scope of criminology, concerning both theoretical systems and methods of research correlated to its applications, as well as to the essential aspects of psychological and sociological disciplines that are involved from an interdisciplinary perspective so understanding deviant action and its causative context. Moreover, the students should be able to know the essential core concepts and reinterpret them for analysis and deepening the problems in the area of primary, secondary, and tertiary crime and victimization prevention. They will be able to reuse and translate that knowledge and acquired skills to identify and understand the training emergencies and educational issues related to the intervention and the social and educational services in the area of crime and deviance, according to educator professional profile sectors in the public and private organizations that manage and deliver social and health services in residential, semi-residential, homecare, and territorial form, provided by law 328/2000 and the relevant regional laws related to families, children,</p>

immigrants, and those at risk of marginalization and social exclusion or according to educator professional profile in the prison services for adults and children.

These results will be pursued through the use of lectures, seminars, and participation in study initiatives and research of the belonging Department (conferences, seminars, student services, etc. .). The assessment will be through oral tests, divided between diagnostic tests, formative or summative, closely related to the content of the examination and other educational activities.

Applying knowledge and understanding

Students will be able to use appropriately, efficiently, and flexibly criminological knowledge acquired during the course, translating it into professional skills and therefore they will be prepared to grasp the problematic nature of the prevention of deviance, and reduction of social distress and disadvantage looking at educational situations in the context of detention and community sentences alternative to detention, with attention to recidivism risk, analysing them from different perspectives (social, cultural, psychological ones). The aim is to formulate, independently, appropriate intervention hypotheses, and develop, implement, manage and evaluate educational projects, in order to meet the growing educational demand expressed by the social reality and by services directed to persons and communities, concerning subjects particularly at risk and/or particularly vulnerable groups such as minors deviant, immigrants, women, drug addicts, ex-detainees. Furthermore, it will be prepared to plan, organize and establish, implement, manage and evaluate interventions and processes of continuous training in the public and private sectors, with the purpose of deviance and dysfunctional behaviors prevention in organizations such as training in ethical codes and anti-corruption guidelines, etc. The achievement of these objectives will be facilitated by the promotion of moments of group work and exercises.

The assessment will be through oral tests, divided between diagnostic tests, formative or summative, closely related to the content of the examination and other educational activities.

Making informed judgements and choices

Students through the course should develop the ability to use and critically and autonomously apply strategies, techniques, and tools of educational planning, with a specific focus on the assumption of responsibility for their role within the regional network of numerous services to individuals and communities, in the context of adult and juvenile deviance and specifically adult and juvenile crime, starting from penitentiary educator up to community educator. The student through the course should also develop the ability to use and critically and autonomously apply the strategies, techniques, and tools of the continuous training planning and in the field of the education of the infancy and pre-adolescence applying methods and techniques of job and research to manage teaching/learning

	<p>activities. with specific attention to the prevention of adult and juvenile delinquency and socialization to legality. The methods and teaching tools to achieve the objectives set out will be the following: lectures, seminars, practical exercises, and a final examination oral test.</p> <p><i>Communicating knowledge and understanding</i></p> <p>At the end of the course, the student should demonstrate adequate and sufficient relational and communicative competencies and social skills useful for the construction of the educational relationship, group organization and management, teamwork, and interinstitutional connections with particular reference to the prison correctional team, the detainee observation, and treatment teams, and to other community sentences convicted supervision and treatment teams. as well as team working in the field of training applied to the prevention of deviance and socialization to legality in schools and public and private organizations. The methods and teaching tools to achieve the objectives set out will be the following: lectures, seminars, practical exercises, and oral final examination tests.</p> <p><i>Capacities to continue learning</i></p> <p>Students should possess learning skills necessary for their professional development and undertake further study with a high degree of autonomy, especially about the necessary interdisciplinary and multidisciplinary integration required by the discipline and intervention spectrum in the area of crime and deviance. The methods and teaching tools to achieve the objectives set out will be the following: lectures, group work on problems, projects and case studies, and oral final examination test.</p>
