AGREEMENT OF CULTURAL AND SCIENTIFIC COOPERATION BETWEEN THE UNIVERSITY OF BARI ALDO MORO AND THE NATURAL PHARMA INTERNATIONAL SRL SOCIETY, THE WORLD UNIVERSITY OF HUMAN RIGHTS AND HUMAN SCIENCES AND THE FOUNDATION TERESA & LUIGI DE BEAUMONT BONELLI ONLUS.

BETWEEN

The University of Bari “Aldo Moro”, located in Bari, P.zza Umberto I, n.1, P.I.01086760723 C.F. 8002170720, represented by the Rector in office Prof. Antonio Felice Uricchio, born in Bitonto on July 10th, 1961, domiciled for the work at the mentioned University.

AND

The Natural Pharma International SRL Society, located in Via Edgar Allan Poe, 1/A- 40132 Bologna, represented by Dr. Stefano Calamita born in Bitonto on March 28th, 1962, domiciled for the office at the offices.

AND

The World University of Human Rights and Human Sciences- ONU- ngo Branch located in AV Hidalgo, 26 – Col la Villa – Mexico, represented by Dr. Francesco Mavelli, born in Margherita di Savoia on September 28th, 1946, domiciled in Via Rizzon n. 13, c.a.p. 76016 Margherita di Savoia,

AND

The Foundation Teresa & Luigi De Beaumont Bonelli Onlus, C.F. 80065250633, represented by the Director Prof. Giulio Tarro, born in Messina, on July 9th, 1938, domiciled in Via Posillipo, n.286, c.a.p. 80123 Napoli,

GIVEN THAT

The University of Bari Aldo Moro:

- pursues, as the primary purposes, the research and training for the development of critical knowledge, opened to dialogue and interaction between cultures, respecting the freedom of research and teaching;
- promotes collaboration with Universities and foreign and italian research Institutes and it adheres to international networks and consortia;



- supports the international mobility of all its components and takes part in programs aimed at strengthening relations between teachers and students in different countries;
- favors the international characterization of its own courses of study, promoting student mobility, ensuring, in compliance with standards and regulations, the recognition of international educational experiences;
- it is committed to the simplification of procedures, in synergy with the relevant institutional bodies, to facilitate access to its training programs by students and scholars in each country;
- It promotes initiatives of support to the Italian and foreign nationality students through the platform FaD of the centre ADA- University services for e-learning and multimedia;
- promotes the activation of degree courses in collaboration with Universities in other countries to the achievement of joint or multiple degrees and it promotes the revision of educational curricula also in an integrated way with foreign universities;
- adopts adequate tools to facilitate the international distribution of its training activities.

The Natural Pharma International SRL Society, the World University of Human Rights and Human Sciences and the Foundation Teresa & Luigi De Beaumont Bonelli Onlus are dealing with the promotion of international agreements aimed joint educational activities, basic and applied research in the field of prevention and health promotion, in order to support the development and international cooperation with Foreign Countries and in particular in the geographic area of the Maghreb and the Middle East

GIVEN THAT

The University of Bari Aldo Moro, the Natural Pharma International SRL Society, the World University of Human Rights and Human Sciences and the Foundation Teresa & Luigi De Beaumont Bonelli Onlus stipulate and agree as follows, in order to achieve objectives of common interest.

ART.1

The premises are an integral and essential part of this Act.



ART.2

The University of Bari Aldo Moro, the Natural Pharma International SRL Society, the World University of Human Rights and Human Sciences and the Foundation Teresa & Luigi De Beaumont Bonelli Onlus, undertake, while respecting their independence and purpose, to promote and increase the cultural and scientific activities in the field of study courses in Medicine and Surgery (LM41), Dentistry (LM46) and Dental Hygiene (L/SNT 3), of all health area and of Graduate Schools and/or Master, Short Master related to these courses and Search Doctorate.

In particular the parties undertake:

- to support and collaborate in the formation processes, research and health;
- to international development and cooperation in the fields of prevention and health promotion;
 - to the implementation of the Master, Short Master and Summer and Winter School, in the context of the above issues;
 - to provide, within the limits of the laws and regulations of the Institutions that subscribe to, the scientific and educational involvement of the participants (students, undergraduates in Medicine, Dentistry, Dental Hygiene, graduate students, enrolled in Masters and Short Master), in the field of the above disciplines, which enable the cultural and professional exchange in the theory / practice on new methods and clinical surgical and prevention techniques;
 - to provide the training of the participants also through their e-learning platforms for distance learning and the acquisition of the final title, jointly Uniba and the three partners of which above;
 - to promote the teachers / researchers exchange, students and administrative staff, in compliance with the relevant regulations;
 - the realization of joint research projects, scientific publications and information on the specific areas covered by the agreement;

ART.3

The University guarantees insurance coverage for accidents and for third party liability of its staff engaged in activities covered by this Agreement, as well as the students / graduates / postgraduates, and also at the scientific and host educational facilities.



The contractor provides similar insurance coverage to their employees or collaborators in any way involved in carrying out the above activities.

The parties are required to conform to the specifications and safety regulations and codes of conduct in force in the execution venues of the activities related to this Cooperation Agreements.

ART.4

Each university is committed to provide for the funding of its attributable costs arising from activities under this Agreement.

ART.5

The coordination of the activities covered by this Cooperation Agreement is entrusted to the Rector or his Delegate, who will identify the scientific referees to define common initiatives consistent with the objectives of this Agreement.

In particular the scientific referees will take care relations with the contracting party and will undertake to prepare the implementing measures (eg identification of participants, evaluation of curricula, monitoring activities, etc.), in accordance with local regulations.

ART.6

The Agency for External Relations, on the basis of the Memorandum of Understanding between the University of the Studies of Bari Aldo Moro and the Consular Corps of Puglia, Basilicata and Molise, subscribed on 29.10.2015, will ensure strategic alliances, cultural exchanges, investment and initiatives for the support of research and education, to ensure the students useful adequate opportunities to their needs.

ART.7

Either party may, at its sole discretion, terminate this Agreement with notice of at least two months, notified to the other party by written notice.

ART. 8

This Agreement will have duration of three years from the date of signing and will be renewed for an equal period of time, unless terminated by either party to be given at least three months before the expiry.



ART. 9

The parties agree to settle amicably any dispute that may arise from the interpretation of this Agreement.

ART. 10

This Agreement may be modified at any time by common agreement, signed by the Rectors of both Universities in the exercise of its jurisdiction.

ART. 11

The present Cooperation Agreement is formally drawn up in Italian and in English. Both texts are original.

ART.12

This Cooperation Agreement is subject to registration in case of use pursuant to Presidential Decree 131 of 26.04.1986
