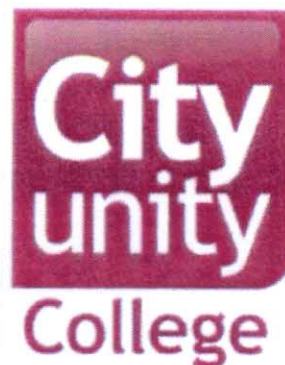
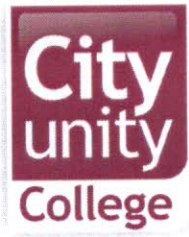

**FOR THE OFFERING OF SPECIFIC FRANCHISE/BLENDED UNIVERSITY OF BARI
ALDO MORO PROGRAMS IN GREECE AND CYPRUS**

The University of Bari Aldo Moro Italy, with its office in Bari, Piazza Umberto I, 1, 70121 Bari, Italy, in the person of Rector, Mr. Antonio Felice Uricchio (hereafter named as THE UNIVERSITY OF BARI).

and

CITY UNITY COLLEGE (CITYU Ekpaideytiki Ltd, Tax code 099632631), Karytsi 1, Syntagma 10561 Athens, Greece, in the person of the President, Mr. Harris Geronikolas (hereafter named as CITYU), representing also CITY UNITY COLLEGE NICOSIA, CYPRUS.

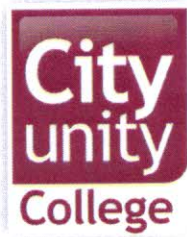
Granted that

THE UNIVERSITY OF BARI ALDO MORO is one of the 58 State universities, was founded in 1925 and is attended today by about 60,000 students, across the Bari, Brindisi, and Taranto campuses.

The University was named after one of its most famous students, the statesman Aldo Moro. Moro taught Criminal Law at the University of Bari for several years.

The University offers various courses for undergraduate, graduate and post-graduate students. Aside from teaching, the university is also focused on scientific research at the doctorate level. The University of Bari research centres are highly-interactive, having connections among different departments, universities, and other research centres.

CITYU is one of the most modern Colleges in Athens, Greece. It was established in 1999 as an official branch of City University of Seattle (USA), an American Accredited University with more than 25 teaching locations worldwide. CITYU at the present date has expanded its academic partnerships and offers a wide range of Undergraduate and Postgraduate programs in the fields of Information Technology, Business, Psychology, Humanities and Education, Theology, Sports Studies, Sports Journalism, Arts, Translation and Interpretation, International Relations and Lobbying in collaboration with accredited universities: City University of Seattle, Liverpool John Moores, University of Wales, Cardiff Metropolitan University, University of Bucharest and University of Strasbourg.

CITYU has been granted the 108276/IA/05-08-2013 (Office Bulletin No. 2019 B') license to operate as a College. Additionally, CITYU has formed, apart from City Unity College (www.cityu.gr / License No: 108276/IA), City Unity Life Long Learning Centre (<http://www.citystudies.gr> / License Code: 2000023), City Unity Private Institute for Professional Training (<http://iekcityu.gr> / License No. 110764/IA) and City Unity Lingua (<http://languages.cityu.gr> / License No: 2305626).

It is agreed as follows:

Art.1

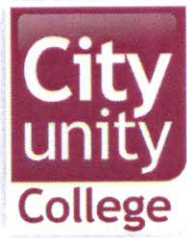
The academic qualifications issued according to the present agreement are issued by THE UNIVERSITY OF BARI.

The University will be fully responsible for:

- the acceptance of students;
- the registration of students at the University;
- the issuing of a registration Certificate and a Student Identification number and ID Card;
- the academic content;
- the issuing of a transcript of studies and a Diploma Supplement with ECTS;
- the processes that all official documents are carrying the Apostille stamp;
- the syllabi of the Programs;
- the didactics;
- the structure of studies;
- the timeframe / duration of studies;
- the approval of CITYU faculty for the teaching of Programs;
- the evaluation processes and
- graduation of students.

CITYU will be fully responsible for:

- all degree recognition and other related issues with the Greek Authorities;

- the delivery of the teaching of Programs under the control and inspection of THE UNIVERSITY OF BARI following also the THE UNIVERSITY OF BARI syllabi;
- the provision of the necessary secretarial and administrative support for the smooth operation of this Agreement;
- the provision of premises where to carry out exams and tutoring;
- the promotion THE UNIVERSITY OF BARI Programs in accordance with the University's policy and procedures;
- the recruitment of prospective students to undertake THE UNIVERSITY OF BARI Programs;
- the accurate provision to prospective students of all necessary information about THE UNIVERSITY OF BARI Programs, didactic model, fees, facilities and services, and assistance in completing and submitting application forms to THE UNIVERSITY OF BARI;
- the provision of any other related services and reports or information requested by THE UNIVERSITY OF BARI or required by this Agreement and
- the bearing of all the cost of advertising and promotional activities under this Agreement.

All Professors that will be responsible from CITYU for the teaching of Programs will be approved by THE UNIVERSITY OF BARI after the suggestion of CITYU.

The cooperation will start with the Program:

- **"Master in Advanced Oral Surgery and Implantology Level II"**

The financial arrangements and other specific details of the Program are included in Annex I.

For each new Program a new Annex will be added to this Agreement with the relevant tuition fees proceeds distribution as well.

The new Programs will be suggested by CITYU.

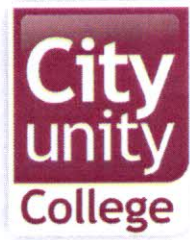
The partnership includes all three cycles of degrees according to the Italian legislation but also cooperation for post doctorate research and other research and funding programs. Short Professional Courses awarding ECTS, proposed by CITYU, may also be added to this partnership.

Art.2

Each franchised Program will be taught in the English and/or the Greek language (s) regardless the language that the original Program of the University is offered. THE UNIVERSITY OF BARI will also examine the possibility of adding the Greek language as one of its official languages and also the creation of a Chair of Hellenic Studies. These expenses will be paid by CITYU.

All Programs are subject to the same quality assurance control and inspection as THE UNIVERSITY OF BARI Programs in Italy. In addition, the relevant quality assurance department / group of the University will monitor, evaluate and access all activities on a constant basis.

Programs will be offered via traditional face to face teaching, by distance learning using an e-learning platform or by blended learning.

The learning processes and the exams of the face to face taught modules will take place with the physical presence of the student at CITYU's premises and will be supervised by a joint Committee formed by Professors from THE UNIVERSITY OF BARI and CITYU. This Committee will also serve as an Exams Commission including both UNIVERSITY OF BARI and CITYU local professors.

CITYU maintains its right to conduct similar agreement(s) for the same or other Programs with other organisations or institutions in Italy and abroad as well.

Faculty / student ratio will also be determined by THE UNIVERSITY OF BARI. For CITYU faculty the exact same standards and qualifications as of THE UNIVERSITY OF BARI faculty will apply.

Art.3

Students will be enrolled and pay the percentage that THE UNIVERSITY OF BARI is entitled, according to the Annex I of this Agreement, directly at THE UNIVERSITY OF BARI. The remaining tuition and fees will be paid by students to CITYU. Any amendment to this policy has to be jointly agreed by both THE UNIVERSITY OF BARI and CITYU.

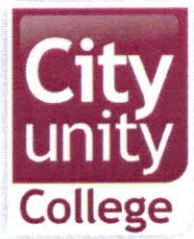
THE UNIVERSITY OF BARI has the right to refuse a student referred to them by CITYU, if there are grounds for believing that the student is not bonafide.

Art.4

The Parties agree to establish an Executive Committee that will be responsible for administrative, technical and financial issues. The Executive Committee will be made up of 4 members, 2 for each of the Parties.

THE UNIVERSITY OF BARI will also apply the necessary processes for monitoring the activities of CITYU, including where corrective action may be required. Additionally, CITYU will not undertake any advertising or promotional activity about THE UNIVERSITY OF BARI Programs without the prior written consent of THE UNIVERSITY OF BARI.

Art.5

The collaboration between THE UNIVERSITY OF BARI and CITYU is an essential condition to ensure the correct realization of the face to face and distance learning teaching models.

The Parties must collaborate in the respect of mutual equality and common benefit, must share results and protect intellectual property rights of both Parties as provided for by international regulations and by the regulations in force in both countries.

The people responsible for carrying out the activities established by this convention shall be Mr. Antonio Felice Uricchio, for THE UNIVERSITY OF BARI, in his capacity of Rector and Mr. Harris Geronikolas, for CITYU, in his capacity of President.

Art.6

In the future, both institutions, under the coordination of the common Executive Committee, will explore the possibility of strengthening their collaboration further with the potential development of new joint Programs and Degrees and the integration of related educational programs and research activities.

Art.7

THE UNIVERSITY OF BARI commits to the treatment, diffusion and communication of the personal data originating from CITYU, for aims exclusively connected to the carrying out of the present convention.

The Official for the treatment of personal data for THE UNIVERSITY OF BARI is its legal representative.

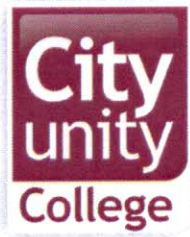
Art.8

The present Agreement lasts ten academic years as from the date of signature and can be renewed on expiry for an equivalent period prior to written notification between the Parties.

Each party can notify in writing to the other Party the cancellation, through a registered letter, with prior notice of at least nine months.

This Agreement may only be altered in writing, signed by both parties.

Art.9

A notice under this Agreement must be in writing and sent by prepaid airmail, fax, or electronic mail to the party at the addresses provided.

A part changing its address, fax number or electronic mail address must give notice of that change to the other part.

Art.10

CITYU must not assign this Agreement or any right under this Agreement without the prior written consent of THE UNIVERSITY OF BARI (which may be withheld at its discretion).

CITYU must not subcontract to any person the performance of any of its obligations under this Agreement with out the prior written consent of THE UNIVERSITY OF BARI (which may be with heldat its discretion).

Despite any subcontract, CITYU remains liable for performing its obligations under this Agreement.

Art.11

If CITYU breaches any provision of this Agreement, THE UNIVERSITY OF BARI may terminate this Agreement at any time with immediate effect by giving to CITYU 9 months prior written notice. In that case, THE UNIVERSITY OF BARI is responsible of providing to active but also to registered students the possibility to finish their studies and graduate from the Program that they are registered.

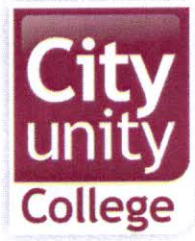
THE UNIVERSITY OF BARI could not terminate any agreement with CITYU and without providing any justification.

CITYU could also immediately take corrective action or terminate any Agreement with THE UNIVERSITY OF BARI as well and without providing any justification, if it becomes aware of THE UNIVERSITY OF BARI being negligent, careless or incompetent or not fulfilling the practices of this Agreement.

On termination of this Agreement, CITYU must:

- submit all applications from prospective students received up to the termination date; and
- immediately cease using any advertising, promotional or other material supplied by THE UNIVERSITY OF BARI and return all material to THE UNIVERSITY OF BARI by registered mail or a reputable international courier.

Art.12

CITYU must keep confidential all information provided by THE UNIVERSITY OF BARI, other than to the extent disclosure is required to perform the services in accordance with this Agreement and the terms of this Agreement.

Art.13

This Agreement shall be governed by and construed and interpreted in accordance with the substantive laws of Italy.

In the event of any dispute or difference arising between the Parties hereto out of or in connection with this Agreement or of its validity or of any documents arising from it or made a part hereof or any amendments thereto, the Parties shall end eavour to reach an amicable agreement, but if such agreement is not reached, there is only jurisdiction of the competent Courts of Italy.

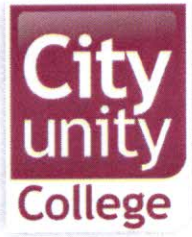
