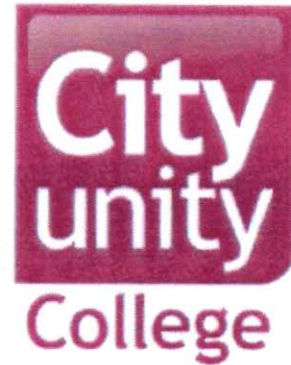
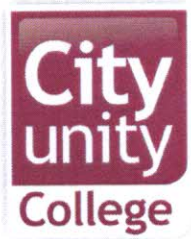

**MEMORANDUM OF UNDERSTANDING (MoU)**

**BETWEEN**

**CITY UNITY COLLEGE GREECE - CYPRUS**

**AND**

**THE UNIVERSITY OF BARI ALDO MORO ITALY**

**CONCERNING**

**THE ESTABLISHMENT OF COOPERATION IN THE FIELD OF EDUCATION, RESEARCH  
AND EDUCATIONAL ACTIVITIES**

**PREAMBLE**

The City Unity College of Athens, Greece – Cyprus and the University of Bari Aldo Moro, Italy here in after referred to as "the Parties",

Inspired by the extensive possibilities offered by international co-operation, recognize the need to develop and nurture new partnership sand to share human and material resources, with the aim to promote international understanding, contribute to the pool of global knowledge and advance the development of our respective countries and the world.

In the spirit of this challenge and responsibility, the parties acknowledge the similarities in the scholarly pursuits of the institutions and desire to promote inter-institutional cooperation, scientific and cultural exchange, and mutual understanding and respect between the citizens of Greece and Italy.

The Parties

**HAVE AGREED AS FOLLOWS:**

**Paragraph 1**

The Parties shall establish and encourage mutually beneficial scientific, technological, educational and other relations based on the following activities:

- a) Offering academic and professional programs of the University of Bari Aldo Moro, in Greece and Cyprus as franchised programs via face to face, distance learning or blended modes.
- b) Possibility of exchange of academic staff members for the purpose of research, teaching and the presentation of special courses in their fields of specialization.
- c) Establishment of joint academic and research programs.
- d) Possibility of exchange of students (under graduate and post graduate) in respect of specific research projects or courses of interest and importance.
- e) Exchange of scientific and educational literature produced by either or both of the parties, as well as the exchange of material on the most relevant and topical research undertaken by researchers of both Parties.
- f) Organization of conferences, seminars and symposia of mutual interest to the Parties.
- g) Organization of doctoral and post doctoral studies for City Unity's researchers.
- h) Organization of new joint First and Second Cycle Degrees to be offered in Greece and Cyprus via face to face, distance learning or blended modes.





## Paragraph 2

The Programs that will be implemented as a result of the MoU will derive from the following faculties and academic domains of the University of Bari Aldo Moro: health and biomedical sciences, economics, finance and business, informatics, social, legal and humanitarian sciences.

The implementation of the MoU will start with the following Second Level Master Program:

- **“Master in Advanced Oral Surgery and Implantology Level II”**

The organization of studies of the agreed project indicated above will be decided by both parties after mutual consent.

Tuition fees proceeds distribution for the Program will be mentioned in the Annex of the future Convention / Agreement between the two parties.

## Paragraph 3

The parties agree to establish an Executive Committee that will be responsible for the implementation of this MoU and the drafting and ratification of a Convention / Agreement between the two institutions for each of the Programs that will be implemented. This Executive Committee will be made up of 4 members, 2 for each of the parties and will be also responsible for all administrative, technical, financial and quality assurance issues.

The Executive Committee / representatives of the Parties, or their authorized substitutes, shall meet frequently at suitable times to evaluate the implementation of this MoU and to decide on changes or additions thereto, which will not come into force unless are made in writing and signed by the representatives of the Parties.

## Paragraph 4

In each case, the theme for a joint activity; the conditions for utilizing results obtained; or arrangements for a visit, exchange and other forms of cooperation shall be determined



collaboratively by the management and scholars of the Parties and the Executive Committee and will be the subject to an additional agreement.

#### **Paragraph 5**

The Parties agreed that financial arrangements will be negotiated on a case by case basis and will depend on the availability of funds.

The Parties will aim to find financial sources for the activities and exchanges to be undertaken in terms of this MoU.

#### **Paragraph 6**

The parties must collaborate in the respect of mutual equality and common benefit, must share results and protect intellectual property rights of both parties as provided for by international regulations and by the regulations in force in both countries.

#### **Paragraph 7**

This MOU shall be governed by and construed and interpreted in accordance with the substantive laws of Italy.

In the event of any dispute or difference arising between the Parties hereto out of or in connection with this MOU or of its validity or of any documents arising from it or made a part hereof or any amendments thereto, the Parties shall endeavor to reach an amicable agreement, but if such agreement is not reached, there is only jurisdiction of the competent Courts of Italy.


**Paragraph 8**

This MoU shall come into effect when the authorized representatives of the Parties have signed it and shall be valid for a period of 5 years. Either party may however, withdraw from the MoU by giving written notice before 30 June of any year of its intention to withdraw with effect from the beginning of the next calendar year.

This MoU is signed in two originals in English language.


