- 7) REAL RIGHTS OF WARRANTY AND LEGITIMATE CAUSES OF FIRST REFUSAL: PRIVILEGE, PLEDGE AND MORTGAGE.
- 8) CONTRACT FREEDOM OF CONTRACT; PARTS OF A CONTRACT, CONTRACT EFFECTIVENESS, NULLITY AND VOIDABILITY OF A CONTRACT; RESCISSION AND TERMINATION OF A CONTRACT; INDIVIDUAL CONTRACTS.
- 9) ADVERTISING AND TRANSCRIPTION.
- 10) CONTRACTUAL LIABILITY, PRE-CONTRACTUAL LIABILITY, TORT OR AQUILIANA LIABILITY.
