The University of Bari is hosting the 11th edition of the conference on the Economics of Global Interactions. The conference is co-organized with the Centre for Experimental Research on Fairness, Inequality, and Rationality (FAIR) at NHH Norwegian School of Economics (Bergen, Norway) and Master E.G.E.I. (www.master-egei.eu).

The event will provide scholars with the opportunity to discuss their recent contributions in the following areas:
