The conference will take place at the University of Bari and CIHEAM Bari in Italy.

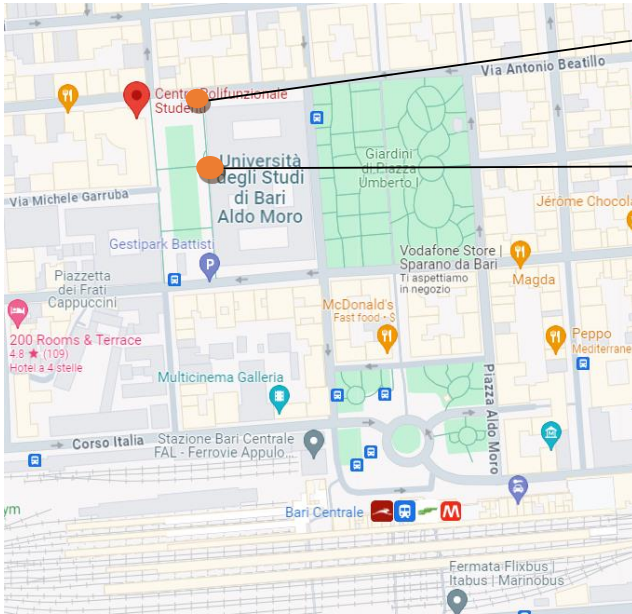

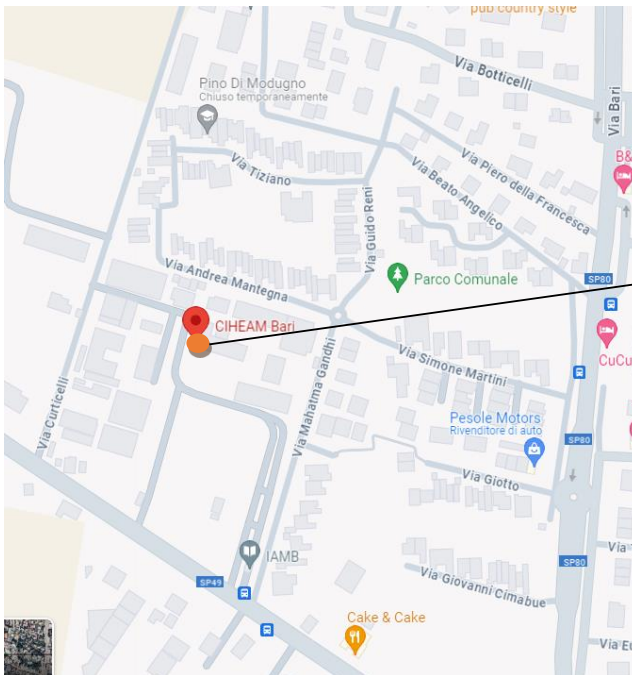
