Rector Decree n.2235

THE RECTOR

CONSIDERING the Statute of the University of Bari Aldo Moro;

CONSIDERING the Law of 3 July 1998, No. 210, in particular Art. 4;

CONSIDERING the Law of December 30, 2010, No. 240 and in particular Art. 19;

CONSIDERING the M.D. No. 45 of 8 February 2013 "Rules on accreditation of doctoral venues and programmes and criteria for the institution of doctoral programmes by accredited bodies";

CONSIDERING the Ethical Code of this University;

CONSIDERING the Regulations of the University of Bari on PhDs, issued by R.D. No. 1154 of 19 April 2018;

CONSIDERING the resolutions adopted by the Academic Senate and the Board of Directors respectively in the sessions of 14 May 2020 and 15 May 2020 regarding the subdivision of scholarships for PhD courses (XXXVI cycle);

CONSIDERING the R.D. n. 1870 of 21 July 2020 with which this University has held public competitions for admission to PhD courses (XXXVI cycle);

CONSIDERING the R.D. n. 2233 of 31 July 2020 by which the proposal of the company POLLUTION SRL of Budrio(BO) for the activation of a position with a higher education apprenticeship contract for the doctoral course in CHEMICAL AND MOLECULAR SCIENCES XXXVI cycle has been accepted -A.A. 2020/2021- for the following research topic: Development of a highly innovative technology to support the monitoring of "odour annoyance" - and, moreover, the positions available for the competition have been extended- for admission to the aforementioned doctoral course- from 10 to 11;

CONSIDERING the R.D. n. 2234 of 31 August 2020 by which the proposal of the company SIDEA GROUP srl in Fasano

(BR) have been accepted in order to activate a position with a higher education apprenticeship contract for the doctoral course in Computer Science and Mathematics XXXVI cycle - A.A. 2020/2021 for the following topic "Human Factors in Digital Transformation" and the proposal of the company CYBERTECH srl in Rome in order to activate a position with a higher education apprenticeship contract for the same doctoral course, for the topic "Cyber Security in Health Care" and, moreover, the available positions for the competition have been extended, from 6 to 8 for the admission to the aforementioned doctoral course;

CONSIDERING the Protocol signed between the company POLLUTION srl in Budrio (BO) and the University of Bari Aldo Moro, to create high-level apprenticeship courses, whose aim is that of stipulating an apprenticeship contract as part of the doctoral course in CHEMICAL AND MOLECULAR SCIENCES-XXXVI cycle-A.A. 2020/2021;

CONSIDERING the Protocol signed between the company SIDEA GROUP srl in Fasano (BR) and the University of Bari Aldo Moro, to create high-level apprenticeship courses, whose aim is that of stipulating an apprenticeship contract as part of the doctoral course in COMPUTER SCIENCE AND MATHEMATICS-XXXVI cycle-A.A. 2020/2021;

CONSIDERING the Protocol signed between the company CYBERTECH srl in Rome and the University of Bari Aldo Moro, for the realization of high-level apprenticeship courses, aimed at stipulating an apprenticeship contract as part of the doctoral course in COMPUTER SCIENCE AND MATHEMATICS-XXXVI cycle-A.A. 2020/2021;

ACKNOWLEDGED it is necessary to proceed with the integration of the selection announcement and in particular of the annexes n.9 (form of the doctoral course COMPUTER SCIENCE AND MATHEMATICS) and n. 16 (form of the doctoral course CHEMICAL AND MOLECULAR SCIENCES PhD);

CONSIDERING the particular urgency to take action on the matter

D E C R E E S

- to modify the annex n. 9 of the call for applications relating to the PhD course in Computer Science and Mathematics, as annex 9/1, an integral part of this decree, by integrating with the provision for the curriculum 1 of a position covered with a higher education apprenticeship contract to be formalized with the SIDEA GROUP company in Fasano (BR) for the topic "Human Factors in Digital Transformation" and a position covered with a higher education apprenticeship contract to be formalized

- with the CYBERTECH company in Rome for the topic "Cyber Security in Health Care";
- to modify the annex n. 16 of the call for applications relating to the PhD course in CHEMICAL AND MOLECULAR SCIENCES, as annex 16/1, an integral part of this decree, by integrating with the provision, for the curriculum 1, of a position covered with a higher education apprenticeship contract to be formalized with the POLLUTION company of Budrio (BO) for the topic "Development of a highly innovative technology to support the monitoring of "odour annoyance";
 - candidates who have applied for the aforementioned doctoral courses will be invited to express their interest for the aforementioned positions covered with a higher education apprenticeship contract.
