Main Goal

To identify a call and conceive a project in response to the call for solving a defined problem and support its feasibility with a viable roadmap



Make the objectives S.M.A.R.T.

Specific: Specify the target group and factors that need to be changed

Measurable: Formulate objectives in a measurable format

Appropriate: Make sure objectives are achievable and acceptable for the target group

Realistic: Ensure that you can realistically achieve the objectives given the project's resources: time, money, staff?

Time bound: Connect objectives to a timeline



Indicators

- Used to measure the performance of the project
- Should be directly linked to the specific objectives
- They are needed to measure level to which the objective is reached
