**ANNOUNCEMENT FOR THE ASSIGNMENT OF 30 SCHOLARSHIPS FOR
INTERNATIONAL STUDENTS**

ART. 1 - Subject, amount and duration

In order to promote the presence of international students in their courses of study, the University of Bari establishes n. 30 scholarships for international students, who are enrolled in the course for the academic year 2015-2016 to the first cycle degree courses and master degree courses of the University of Bari Aldo Moro. Each scholarships amounts to € 490.80.

ART. 2 - Admission requirements to the selection

To participate in the selection is required, under penalty of exclusion, enrollment for the 2015/16 academic year at one of the activated studies courses at this University, irrespective of their nationality, and residence permit valid.

Students must be enrolled by a number of years not exceeding the legal duration of the course, they have acquired by 30 October 2016 at least 2/5 of the credits provided by the study plan, with reference to previous years, including the 2015/16 academic year.

By way of example, the minimum number of credits that the student must have in his career to 30 October 2016 must be equal to:

The partial examinations will be excluded from the calculation.

The credits deriving from compounds exams from multiple modules or written tests or oral, will be counted if all modules or both tests are exceeded.

They will be excluded from the selection: students enrolled off course during the academic year 2015/16; students enrolled in courses of individual courses;

ART.3- Submission of applications: terms and conditions

The application form for selection must be submitted by February 6, 2017, to February 24, 2017, using only the special form attached to this announcement. The application may be sent by registered mail with return receipt, to the following address: University of Bari Aldo Moro, Direzione Offerta Formativa e Servizi agli Studenti, Piazza Umberto I n. 1, 70121 Bari; delivered by hand, from Monday to Friday from 10.00 to 12.00 and Tuesday and Thursday from 15.00 to 17.00, at Area Protocol and Document Management of this University (Palazzo Ateneo, Piazza Umberto I n. 1, 70121 Bari);

Applicants must attach a copy of their passport for EU citizens and/or copy of a valid identification document and a copy of the residence permit.

ART. 4 Award criteria and classification of the rankings

For the evaluation will be calculated a coefficient derived from the product of the average grades for the number of credits actually acquired divided by the number of credits that can be acquired in connection with an enrollment year 2015/2016.

The single list will be formulated according to the above coefficient, in descending order, and to be equal, preference will be the youngest candidate.

ART. 5 - Acceptance

The winners will receive the communication of awarding of the scholarship by e-institutional email.

Within a period of 7 days of receipt of the notification of the granting of scholarship, the assignee must sign under penalty of forfeiture, a special declaration of acceptance at the Foreign Students U.O. – first floor Palazzo Ateneo. (Sig.ra Costanza Mitacchione)

ART. 6 – Mode of payment of the scholarship and retention requirements

The disbursement of scholarships will take place in two installments: the first payment amounting to 245,40 euro will take place in May 2017, the second installment of the same amount in October 2017.

The payment of the scholarships will be made by bank transfer to bank account or prepaid card with Italian IBAN payable or joint account to the beneficiary student.

ART. 7 – Information on data processing

Collected personal data will be processed in accordance with the principles and provisions of the Decree n. 196/2003 regarding the protection of confidentiality and then only for the purposes of management of the insolvency proceedings.

The data processing shall be done by a computer system or manual form through papers. The yield of the requested data is mandatory condition for the management of insolvency proceedings.

The Administration reserves the right to carry out checks on the veracity of the statements. Without prejudice to the penalties provided for by art. 76 of Presidential Decree 445/2000,

where the checks reveal that inaccuracy of the content of the declaration, the applicant loses the bag
